Background of Macro-economic and Socio-economic Assessment



- The 4th RTWG agreed on:
 - Early Development Scenario (2007)
 - Definite Future Scenario (2020)
 - Planned Development Scenario (2040)
 - Each development scenario will be assessed against a triple bottom line (economic, environmental and social) of the MRC Indicator Framework.
 - The Socio-economic Assessment Team that will work closely together with the Economic Assessment Team and the Environmental Assessment Team (currently called Bio-Resource Assessment Team), National Experts and MRC Socio-economic Working Group (BDP leads the discipline team).

The 1st Mission of Macro-economic and Socio-economic Discipline Team



- Period of the 1st Mission
 - 14-26 September 2015
- Objective of the 1st Mission
 - To scope the integrated macro-economic and socio-economic assessment of the agreed scenarios
 - To develop the approach and methodology of the assessment (taking into account the ongoing preparation of the biological resource assessment)

Implementation of the 1st mission

- Meet with the leaders of the other three assessment teams (hydrological, climate change and biological resources).
- Meet with other MRC Programmes (Thematic teams) and others.
- Present the approach, methodology and implementation modalities of the macroeconomic and socio-economic assessment with a view to solicit feed-back and discuss the data acquisition plan and coordination needs.

Output of the 1st mission (1)



The main output of the mission is a report which covers the following information:

- The scoping and approach of the macro-economic and socio-economic assessment;
- The review of the MRC Indicator Framework and the selection of assessment indicators and supporting monitoring parameters;
- The preliminary methodology for evaluation (and preferably quantification) of the selected assessment indicators;

Output of the 1st mission (2)



- The testing of the approach and methodology, based on the 2009-2011 scenario assessment,
- Data acquisition plan for the macro-economic and socioeconomic assessment;
- Implications and guidance for thematic and other discipline teams; and
- Planning of the implementation of the macro-economic and socio-economic assessment.

Challenges



- Development of a practical approach and methodology for the macroeconomic and socioeconomic assessment under the Council Study based on readily available data;
- Integration of the methodology for the macroeconomic and socio-economic assessment with the other assessments under the Council Study.
- Coordinating with other assessment teams led by different programmes and with different consultants

- The draft scoping report will include implications and guidance for thematic and other discipline teams in terms of the information and cooperation needed to implement the social and economic assessments
