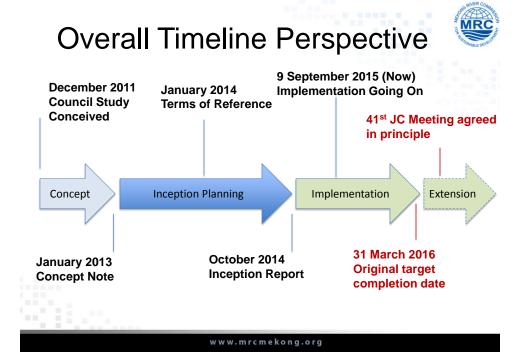


## Objectives

- Promote capacity and ensure technology transfer to Member Countries

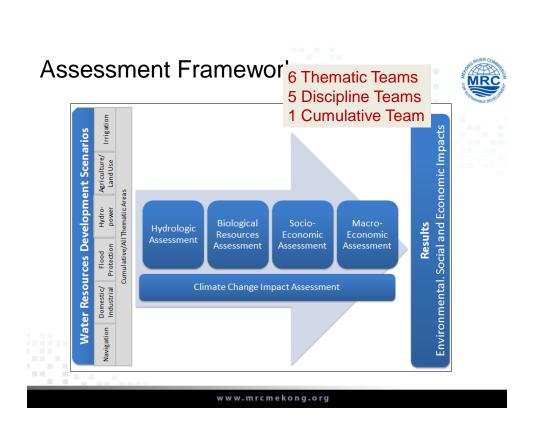


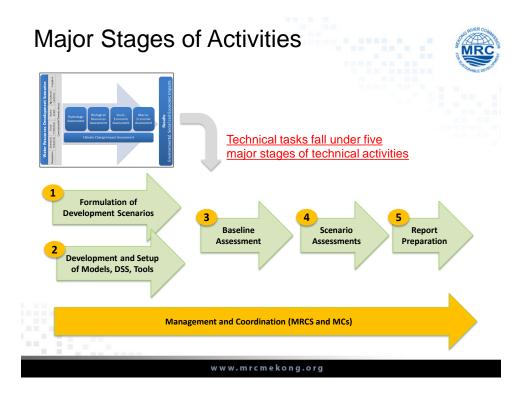




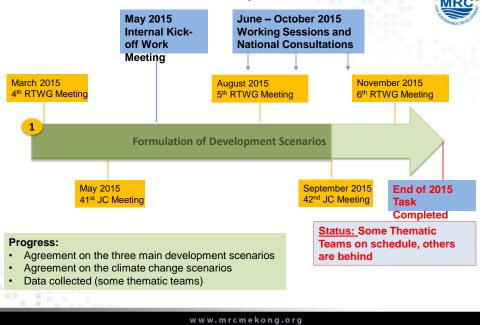


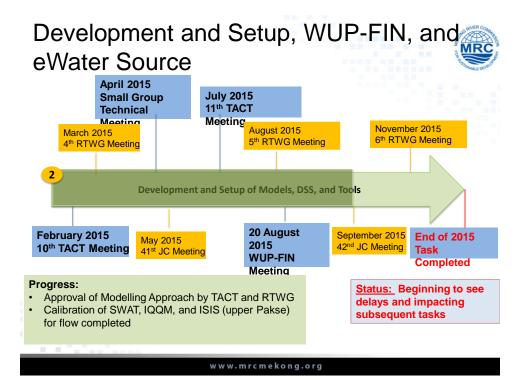

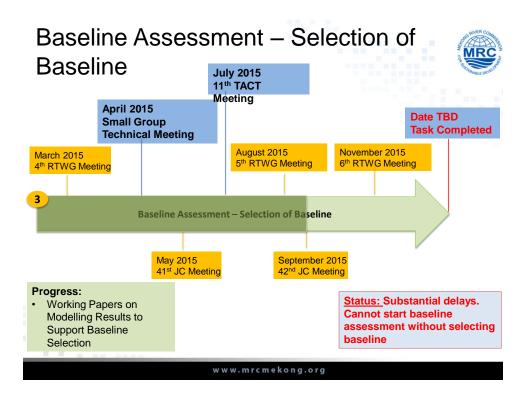




#### Development and Setup of DRIFT DSS for LMB

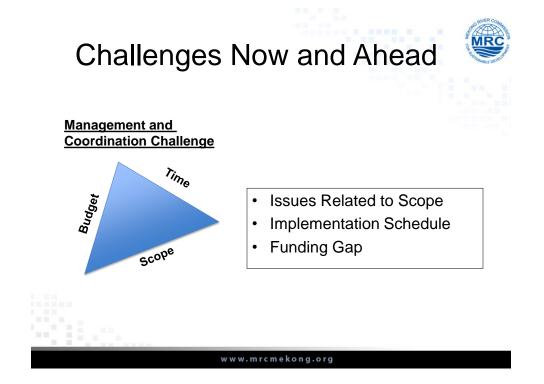

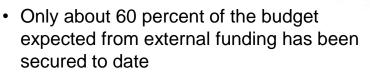

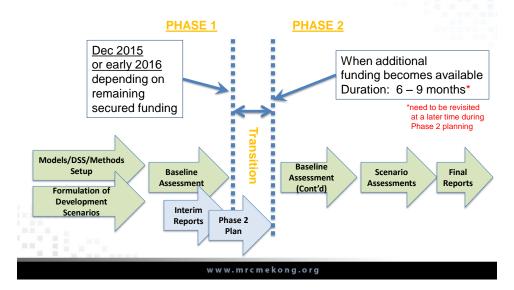
